Purchaser is responsible to pay the entire balance on merchandise for stock or special orders. All balances are to be paid at first fitting or no later than 30 days upon arrival of merchandise into the salon (whichever occurs first). Seller shall not be responsible for manufacturer's size, fabric dye lot variations or default by manufacturer. The purchase price does not include the price of alterations. Charges for alterations must be paid in full at time of first fitting.
